Currently we believes scrip is in consolidation phase near to its crucial support of 100-98 levels. For the upcoming 10-12 months we believe MEGHMANI ORGANICS is well poised for some sharp recovery as its technical indicators already in oversold zone and volume seems to building up gradually. Hence we advised to accumulate this stock around 100-98 and on dips around 65-70 for the price target of Rs 158-160 in 10-12 months.
