**OUTLOOK** Asian markets ended higher on Wednesday as investors digested a raft of economic data and corporate earnings results. Stocks in China ended higher despite the country reporting lower-than-expected manufacturing growth in October. China's official manufacturing PMI fell to 50.2 in October, the lowest since July 2016 and down from 50.8 in September, in a sign of further loss of momentum in the world's second-largest economy. The services PMI dropped from 54.9 to 53.9, marking the weakest pace of expansion since August 2017. Japanese shares hit a one-week high and the yen edged lower against the dollar after the Bank of Japan left interest rates steady, cut its inflation forecasts and signaled it was a long way off from exiting its massive stimulus program. Investors shrugged off weak data showing that industrial production in the country fell 1.1 percent in September from the previous month, missing expectations for a decline of 0.3 percent. Meanwhile, Hong Kong shares rose following a rebound on Wall Street, but logged their worst monthly loss since January 2016 amid a global equity sell-off triggered by concern over the impact of a Sino-American trade war. Meanwhile, expressing optimism over India's ease of doing business ranking, Commerce and Industry Minister Suresh Prabhu indicated at improvement in the country's ranking.

The bull call spread option trading strategy is employed when the options trader thinks that the price of the underlying asset will go up moderately in the near term. Bull call spreads can be implemented by buying an at-the-money call option while simultaneously writing a higher striking out-of-the-money call option of the same underlying security and the same expiration month.

#### Bull Call Spread Construction

Buy 1 ITM Call  
Sell 1 OTM Call

Maximum gain is reached for the bull call spread options strategy when the stock price move above the higher strike price of the two calls and it is equal to the difference between the strike price of the two call options minus the initial debit taken to enter the position.

Max Profit = Strike Price of Short Call - Strike Price of Long Call - Net Premium Paid - Commissions Paid  
Max Profit Achieved When Price of Underlying  $\geq$  Strike Price of Short Call
